Request for Ministerial consent to change of person – Transfer of Approval Holder for Yangibana Rare Earths Project (EPBC 2021/8892)

The referred Yangibana Expansion 1 Project (the **Proposed Action**), located in the Upper Gascoyne region of Western Australia, was declared a controlled action under section 75 of the *Environment Protection and Biodiversity Conservation Act 1999* (**EPBC Act**), on 27 April 2021 (EPBC 2021/8892). The Proposed Action involves the expansion of the mining areas at the Yangibana Rare Earths Project (EPBC 2016/7845). The expansion involves mining from two additional pits (Yangibana and Auer) and one larger amalgamated pit (Bald Hill-Simon's Find – Fraser's). The Proposed Action has to date been currently solely owned and operated by Hastings Technology Metals Limited and its subsidiaries (**Hastings**).

On 15 May 2025, Hastings entered into a transaction agreement with Wyloo Consolidated Investments Pty Ltd (ACN 646 337 439 and ABN 31 646 337 439) and its subsidiaries (**Wyloo**). Upon completion of this transaction agreement, Hastings will transfer 60% of its interest in the leases for the Yangibana Rare Earths Project and Yangibana Expansion 1 (the Yangibana Tenements) to a wholly owned subsidiary of Wyloo, being Wyloo Gascoyne Pty Ltd (**Wyloo Gascoyne**). Hastings will retain 40% ownership of the Project under their 100% owned subsidiary, Yangibana Jubilee Pty Ltd. The transaction is subject to certain conditions being satisfied.

Hastings and Wyloo request your consent under Section 156F of the EPBC Act to formalise a change of person of a referral prior to a decision being made to approve or refuse the Action for "the Yangibana Expansion 1 (EPBC 2021/8892)" from Hastings to Wyloo Gascoyne.

Hastings and Wyloo request that the transfer occurs on, or as soon as practicable after, completion of the transaction referenced above, which is currently scheduled for 1 September 2025. Hastings will advise if the date of completion changes.

Brief Description	The Proposed Action proposes to extent the mining areas at the Yangibana Rare Earths Project (EPBC Approval Received; Ref EPBC 2021/8892). The Proposed Action expansion involves mining, from two additional pits (Yangibana and Auer) and one larger amalgamated pit (Bald Hill-Simon's Find-Fraser's). During mining, the REE containing ore will be taken to the existing process plant, whereas waste rock will be deposited in waste rock landforms, adjacent to each respective pit. Tailings will be disposed in existing approved tailings storage facility.
