PROPOSED MINISTERIAL INFRASTRUCTURE DESIGNATION – BRISBANE CATHOLIC EDUCATION - CATHOLIC COLLEGE, NARANGBA

The Hon Meaghan Scanlan, Minister for Housing, Local Government and Planning and Minister for Public Works, is proposing an Infrastructure Designation for the site at 2-34 & 40 Morgan Road and 156,166,168 & 176 Callaghan Road, Narangba which is to become a new master-planned prep to year 12 school, childcare centre and church under Chapter 2, Part 5 of the *Planning Act 2016*.

Description of Proposal	 This designation seeks to establish a new master-planned school, childcare centre and church (building heights ranging from 1-3 storeys) are proposed. The College will include: Teaching buildings, including: 4 junior classroom buildings; 5 secondary classroom buildings – including specialist buildings; 1 prep building; Childcare centre/OSHC building; Administration, library and maintenance buildings; Tuckshop facilities; Undercover education and play areas; Grassed primary school field; Sporting field - including athletics track and tiered seating; Central courtyard; and Provision for a potential future Church in the south-western corner of the site.
